- 1) The Breeders warrant that the above Sire & Dam have been hip scored and eye tested (clear) in accordance with the KC/BVA schemes. **Copies of these certificates are attached.**
- 2) The Purchaser(s) warrants that they are purchasing the above dog for themselves and not as agents for a third party.
- 3) The purchaser(s) agree to care properly for the above dog and make every effort to ensure that it will be regularly socialised and attend training and/or ring craft classes. If, for any reason the Purchaser(s) experiences any difficulties they undertake to contact the Breeders immediately and inform them.
- 4) **The Purchaser(s) is/aware that the above dog is not to be exported from the United Kingdom, that it is not to be bred from, and its Kennel Club Registration document will be endorsed accordingly**
- 5) Stipulations as to the lifting of breeding restrictions are as follows:
  - The above dog must have its hips scored and its eyes tested in accordance with KC/BVA schemes. The Breeders must receive copies of both certificates and the hip score must be published in the Kennel Club Breeds Record Supplement.
  - The breeders will require a written statement from a Veterinary surgeon confirming the dog is in good health, has a correct bite i.e. a scissors bite, and that it displays no other obvious health problems that may be passed on to any subsequent offspring.
  - The dog must have been shown in conformation classes at Championship Show level and be proven to have been consistently successful.
  - The breeder's must also approve the dog/bitch that it is to be bred with. The Purchaser(s) understand(s) that if any of the above conditions are not to the Breeders satisfaction, then the Breeders reserve the right to refuse permission to breed from the above dog. Written permission must then be obtained for all subsequent breeding.
- 6) The above dog will never be bred with any other dog other than a pure bred Alaskan Malamute.
- 7) If the purchaser(s) is/are unable to care for the above dog, for any reason, or it is necessary to re-home the dog, the Purchaser(s) agree(s) that the dog will be returned to the Breeders without delay, and, under no circumstances will it be passed on to any third party.
- 8) The Purchaser(s) is/are aware that if they are unable to care for the above dog any longer and it is necessary for the dog to be returned to the Breeders, the Breeders agree to take back, feed, house and care for, the above dog. If, after assessment, the Breeders feel that the dog is suitable to be placed with new owners, the breeders will assume the responsibility of this re-homing, and will reimburse the original Purchaser(s) the re-homing fee received from any new owner(s), minus kennelling fees incurred during the dog's stay with the Breeders.

**UNDER NO CIRCUMSTANCES WILL THE DOG BE REHOMED TO ANYONE BUT THE BREEDERS**

**NOTE:** Every care has been taken in the breeding and rearing of the above dog, and every effort has been made, by the Breeders to eliminate hereditary conditions from the breeding stock.

No warranty can, however, be given, as specialist examination cannot accurately be undertaken before twelve months of age.
